

Woods Hole Sea Grant Program Overview







RFP Priority Areas

Other emerging themes are also acceptable to submit to Woods Hole Sea Grant (WHSG). Proposals on topics other than the priority areas will also be reviewed by external experts and the convened review panel.

As you are developing research project ideas, we strongly suggest you consider potential management applications of the results of your research, and craft a research project around critical management needs of coastal communities in Massachusetts.



RFP details


- Lead PIs must be staff or faculty at any public or private research or higher educational institution within the state of Massachusetts.
- Researchers are eligible to submit only one pre-proposal as lead PI, but may serve as a co-PI on other proposals.
- Approximately \$500,000 per year will be available to support 5-10 research projects during the 2022-2024 funding cycle.
- Sea Grant proposals require a match of \$1 of non-federal funds for every \$2 of federal funds requested.






- Proposals must include a plan for disseminating findings and/or products to relevant stakeholders (non-academic). If this is new to you, contact us with your idea and we can help put you in touch with relevant parties.
- PIs are encouraged to work with WHSG's staff to identify and contact communities, individuals and organizations that will benefit from project outcomes.
- Funded investigators will be paired with a member of our staff and will be encouraged to maintain an informal line of communication with the staff member during the course of the study period.
- Annual research meeting with Sea Grant staff to summarize results as a means to align research and outreach efforts.











FAQs for Developing an Engagement Plan for a Woods Hole Sea Grant Research Project

What is stakeholder outreach and engagement?

Stakeholder outreach and engagement are terms that describe elements of communicating your research results to relevant stakeholders that include interested communities, organizations, and individuals.

Who are stakeholders?

Stakeholders are individuals who use Massachusetts' coastal resources - stakeholder groups could include K-12 students, parents and/or teachers, coastal managers, members of coastal industries or business owners, or the general public, among others.

What are the key elements of a stakeholder engagement plan?

Stakeholder engagement plans should provide detailed strategies for working with and communicating the results of your research to relevant stakeholder groups. A well crafted stakeholder engagement plan will ensure that your research results have a clear path for use by relevant communities in Massachusetts.





Proposal Review Process

- Pre-proposals:
 - Reviewed by a panel of experts including WHSG staff and members of WHSG's advisory board
 - Reviewed for:
 - Relevance to our program and strategic plan (50%)
 - Scientific and technical merit (25%)
 - Strength of potential engagement plan (25%)



Proposal Review Process

- Full proposals:
 - Reviewed by external mail technical experts. A panel is convened to interpret the technical reviews and rank proposals.
 - Evaluated for:
 - Rationale and innovativeness (20%)
 - Scientific and technical merit (25%)
 - Qualification of the research team and results from prior work funded by Woods Hole Sea Grant (if applicable) (10%)
 - Program relevance (20%)
 - Potential impact to Massachusetts stakeholders (25%)



Key Dates

- Friday, February 19: Preliminary proposals due to Woods Hole Sea Grant office by 4:30 p.m. Submit pre-proposal in pdf format to seagrant-research@whoi.edu.
- No later than mid-April: Principal Investigators receive recommendations regarding development of full proposals.
- Friday, May 21: List of five potential reviewers due to <u>seagrant-research@whoi.edu</u>.
- Friday, May 28: Full proposals due in Woods Hole Sea Grant office by 4:30 p.m. Submit full proposals to seagrant-research@whoi.edu.
- Early October 2021: Applicants informed of decisions.
- February 1, 2022: Anticipated 2022-2024 awards begin.
